POSTAL SERVICE HEARS BIG OUTCRY OVER PLAN TO MOVE MAIL PROCESSING OUT OF WYOMING

One thing is for certain: Wyoming is not going down without a fight. The Postal Service's plan to move mail processing and distribution to other states is getting big pushback from Wyoming residents and the bureaucrats are hearing it.

Working behind the scenes, Ricci Roberts, branch president of the Cheyenne mail handling unit, believes the public outcry, after it was announced Cheyenne's mail service is being downgraded, is beginning to gain some traction.

The U.S. Postal Service earlier this month announced a proposal to downgrade Cheyenne's mail processing from a processing and distribution center, and moving that work to Denver. Cheyenne would remain open, but transition to a local processing unit instead of being its own distribution center. Similar changes are proposed at a later time for Casper, with that mail processing moving to Billings instead.

The changes would leave the Cowboy State without a processing and distribution center, despite the fact it's on a growth track with new businesses coming in across the state...

In a Facebook post, Roberts wrote that the public's efforts have been "VERY instrumental and helpful," prompting a number of Wyoming officials to take notice...

Lummis said Wyoming has already seen an example of how these proposed changes will go, when western Wyoming's mail sorting activities were transferred from Rock Springs to Salt Lake City.

"Since then, mail services have been severely impacted," she wrote. "And deliveries are often delayed by weeks."

Lummis also blasted the Postal Service for what has largely been an opaque process, one that hasn't included answers to the questions that people have.

At a recent forum to gather public comments, postal officials even told the attendees the forum's focus was on collecting comments from the public, not answering questions. No forum has yet been set for answering any of the questions that the public has...

'ENOUGH IS ENOUGH: MILWAUKEE USPS WORKERS HOLD RALLY TO PROTEST HOSTILE WORK ENVIRONMENTS

MILWAUKEE (CBS 58, Nov. 5, 2023) -- A hostile work environment, wage thefts, and unfair disciplinary actions are just some of the working conditions that Milwaukee USPS workers claimed on Sunday they've faced for years.

Dozens joined forces outside of the post office on W. St. Paul Ave. in downtown Milwaukee for a rally Nov. 5, with many holding signs and chanting.

"Basically, we're asking to be treated with basic human dignity," said letter carrier Travis Albert, who co-hosted the event. "I'm a union steward -- carriers come to me daily, red-faced and shaking, often on the verge of tears or in tears; I've been in disciplinary hearings where carriers have expressed suicidal thoughts out loud all in regard to the workplace conditions."

Albert told CBS 58 the goal of the rally was to shed light on what workers have been forced to deal with, adding that "enough is enough."

"We've had numerous assaults out on the street, and we feel like those have not been taken seriously," Albert said. "We even have a hard time getting management to answer the phones whenever there's an emergency situation."

That, plus claims of wage thefts of employees...

Multiple city leaders also came out to show support at the rally. "Every person at work is entitled to and should get safety on the job," said Supervisor Ryan Clancy of Milwaukee's 4th District.

Pam Fendt, the president of the Milwaukee Area Labor Council, agreed, noting that "the issues you are facing are very serious and they need to be brought to light."

PMG Louis DeJoy is rolling out a massive consolidation of postal facilities into large Sorting and Delivery Centers, which will displace letter carriers from their local post offices, excess clerks and disrupt retail service.

Currently none of the national postal unions nor any Congressional committees are calling for national hearings on this Sorting & Delivery Center transformation. So, it's up to us to build pressure to slow, pause or stop this bad plan.

STATEMENT FROM APWU GENERAL OFFICERS ON THE CONFLICT IN ISRAEL AND PALESTINE November 8, 2023

The American Postal Workers Union is shocked and saddened by the tragic and ongoing violence in Israel and Palestine. As working people, we stand with the oppressed and the innocent, thousands of whom have lost their lives in the last month.

As a union that stands for equality, social justice, human and labor rights, and international solidarity, we unite with unions and people of goodwill around the world in calls for justice and peace.

We unreservedly condemn the Hamas violence of October 7, which killed over 1,000 Israeli civilians and saw the kidnapping of more than 200 people.

However, Israel's response has made the prospects for peace more remote. Over 10,000 innocent civilians, including 4000 children, have been killed by the relentless and indiscriminate bombing campaign on Gaza. Israel has shut off the flow of food, water, fuel and medical supplies to the Gaza Strip, a war crime. A humanitarian catastrophe is unfolding every day in Gaza. Thousands more innocent civilians stand to die wholly preventable deaths.

We call on our government, which is the primary foreign benefactor of the Israeli government, to use all its power to protect innocent lives and to help bring about peace in the region, and not use our tax dollars for more war.

We join the calls for an immediate ceasefire, the release of hostages, and urgently needed massive humanitarian aid to the people of Gaza. The cries of humanity demand nothing less.
